

Safety Services Building Committee
June 5, 2019
Subcommittee to prepare Public Meeting Presentation

Mr. Healey started the meeting at 7:00 p.m.

Dick Wright attended meeting. Mr. Healey invited Mr. Wright to the table.

Pam Bryk showed the committee the Facebook page she designed which is called Newbury NH Safety Service Building Project. Ms. Bryk did a first post and will be doing frequent posts about the status of the SSB Committee and the status of the project to construct a new Fire Station.

Slide 21 Take part of slide concerning affect of new debt for new Fire Station, Library building expansion and renovation of current SS building for the PD and other town uses on RE tax and make separate slide and a few other changes
